

INTRODUCTION



Safe Routes to School (SRTS) is a comprehensive K-12th grade program to make school communities safer by combining engineering tools and engagement with education about safety and activities to enable and encourage students to walk and roll to school. SRTS programs involve partnerships among municipalities, school districts, transit districts, parks and recreation districts, public health agencies, community members, parent volunteers, and community groups.

The benefits of implementing a SRTS Plan include improving safety, increasing access, encouraging physical activity, and reducing traffic congestion and motor vehicle emissions near schools. Implementing SRTS programs and projects benefits adjacent neighborhoods, as well as students and their families, by reducing traffic conflicts and enabling walking and rolling trips for all purposes.

## Safe Routes to School Background

This document serves as a guide for the continued promotion of SRTS programs in North Wasco County School District with a specific focus on education programs. This will be a guiding document for the SRTS Coordinator to guide educational programming starting with the 2023–2024 school year and beyond. This document will help the SRTS Coordinator prioritize meaningful partnerships and activities based on community need for services.

The recommendations in this document are built upon previous SRTS programs in North Wasco County, including:

- ≥ 2020: North Wasco County School District was selected to participate in the ODOT SRTS Project Identification Program resulting in a SRTS Plan completed in 2022 for the City.
- ≥ 2022: The City of The Dalles was selected as a pilot community for the Oregon Department of Transportation (ODOT) SRTS Quick Build Program, which created additional pedestrian protection at the intersection of 16th Street and Trevitt Street, adjacent to Colonel Wright Elementary School.
- 2022: North Wasco County School District was awarded a Tier 1 ODOT Education Grant to fund a SRTS Coordinator and develop this strategy.
- 2022: The City of The Dalles was awarded an ODOT SRTS Construction Grant for bicycle and pedestrian improvements near Chenowith Elementary.
- 2022: Chenowith Elementary hosts their first walking school bus.



## North Wasco County School District Demographics

North Wasco County School District served 2,752 enrolled students in 2023 throughout its eight schools. Schools are located in and around the City of The Dalles.

Enrollment for the 2022-2023 school year included:

North Wasco County School District schools have an average of 60% to 85% of families below the poverty line. The District met the low-income threshold for the federal Community Eligibility Provision, which is only available to the nation's highest poverty schools and districts.

The District also has a greatly diverse student population, with a significantly high average of 50% BIPOC (Black, Indigenous, and People of Color)

students district-wide. Also, 14.7% of enrolled students in 2023 were English Language Learners and 17.7% were Migrant Students. The District and partnering agencies provide special programming for these students, and a culturally appropriate SRTS program is needed to meet the needs of students and the community.

## **Barriers to SRTS in The Dalles**

North Wasco County School District's six schools are located in the rural City of The Dalles. Heavy passenger vehicle traffic, high speeds, insufficient bicycle and pedestrian infrastructure can create significant barriers for students trying to commute to school safely. There are limited sidewalks within a one-mile radius of many North Wasco County schools resulting in students who walk to school having to walk on the shoulder. The District's crash history shows three fatal crashes and 15 minor crashes within school neighborhoods. Though most families live within a mile of their school, many choose to drive because of road safety concerns.

To address these issues, a holistic approach to the SRTS program is needed at North Wasco County School District and in the local community. SRTS programs aim to improve the safety and accessibility of walking and biking routes to school. These initiatives typically involve a combination of infrastructure improvements, educational efforts, and community engagement to promote active transportation and address traffic safety concerns.






# SRTS PARTNERSHIPS AND COORDINATION

Community buy-in and participation is essential to the success of Safe Routes to School. The SRTS Coordinator will use the following tools to communicate with the wider community on program updates and offerings:

- Attend back-to-school nights and other school-related events where the SRTS program can host a table of information and activities.
- Share program vision and goals on web page and through community social media and newsletter channels.



## **School District Involvement in SRTS**

The North Wasco County School District is heavily involved in SRTS, having demonstrated commitment by securing an ODOT Education Grant (Tier 1), which enabled the District to hire a full-time SRTS Coordinator. North Wasco School District has offered their support to the SRTS Coordinator through:

- Coordinating with school administration to send emails to families about SRTS activities and messaging
- Distributing parent/caregiver surveys to understand transportation behavior and barriers.

- - » Hosting SRTS events at the district level for all schools
  - » Scheduling Bicycle and Pedestrian Education for PE teachers through the Jump Start Train the Trainer program
  - » Providing space and tables during arrival or dismissal, All Parent Nights, and other major existing events

# Community Organization Involvement in SRTS

Several community-based organizations and government agencies support the SRTS Coordinator and collaborate on building the North Wasco School District SRTS program. These partnerships are important in creating a holistic program that reaches a diversity of people in The Dalles. The program would not be possible without these partnerships.

The following organizations have participated in four SRTS Coalition meetings through spring and summer 2023:

- ▷ City of the Dalles
- Mid-Columbia Economic Development District (MCEDD)
- ▶ The Dalles Area Chamber of Commerce
- North Central Public Health District (NCPHD)





## City of the Dalles

The City of the Dalles' continuous support of SRTS is vital for program sustainability and effectiveness. The City of the Dalles has offered their support to North Wasco County's Safe Routes to School program in the following ways:

- □ Integrating SRTS recommendations from the Project Identification Program into future planning efforts
- ▷ Involving SRTS representatives in future planning efforts to include considerations for improved school access
- Continuing to seek funding for transportation improvements that benefit school access
- ▷ Providing traffic control for SRTS events through the police department.
- ▶ Participating in existing citywide events including All Parents Nights and Safe Kids events
- ▷ Identifying solutions to transportation barriers identified in parent/caregiver surveys
- ▷ Participating in community partner meetings



#### **MCEDD**

- ▶ Identify funding sources and assisting with grant writing

## The Dalles Area Chamber of Commerce

The Dalles Area Chamber of Commerce works to advance agricultural, professional, commercial, industrial, civic, tourism, and general interest in The Dalles area and region. The Chamber of Commerce has offered their support in connecting local bicycle shops to help with SRTS events and bicycle repairs for students.

### **NCPHD**

NCPHD serves Wasco and Sherman Counties with a mission to prevent, promote, and protect for a thriving community. The NCPHD has offered their support in the following ways:

- Sharing information on website and social media channels about Walk+Roll events
- Sharing historical context around SRTS in the area
   and ideas for engaging teachers
- Sharing or donating a-frame signs and other materials for events
- Connecting Safe Routes to School with existing events, such as Get Ready The Dalles, an emergency preparedness event hosted annually





## SRTS PROGRAM ACTIVITIES AND PRIORITIES

These goals and actions were developed in collaboration with the North Wasco County SRTS Coordinator following conversations during the Coalition meetings. This strategy is intended to be a guiding document for the 2023–2024 school year in order to prioritize actions and program activities and involve necessary partners. The Coalition provided feedback on the following goals and actions during their third meeting together. These goals and actions are intended to build a strong foundation for the program and to prepare to apply for future grant funding including Tier 2 ODOT Education Grant in 2024.

Goal 1: Increase the number of families safely using active transportation for the school commute through educational communications and events

## NEXT STEPS AND SUSTAINABILITY

## **SRTS Program Structure**



The Safe Routes to School Coalition will be led by the SRTS Coordinator to meet monthly throughout the 2023–2024 school year to discuss upcoming events, troubleshoot transportation challenges in the community, and support the program overall.

In spring 2024, North Wasco County School District will be eligible to apply for a Tier 2 ODOT Education Grant, which can continue to fund the SRTS Coordinator position for the 2024–2025 and 2025–2026 school years. Some steps that the SRTS Coordinator can take to prepare for a Tier 2 grant include:

- ▷ Attend the January 2024 webinar about ODOT SRTS grants
- Consider what elements of the North Wasco SRTS program can be deepened and expanded upon in the coming two years
- Discuss program evaluation with Coalition members and opportunities for growth

## **Funding Opportunities**

In addition to the ODOT Education Grant, there are other opportunities to fund various aspects of the North Wasco County School District SRTS

program from educational materials to campaigns to infrastructure. The table below outlines opportunities for funding and sustaining this SRTS program.
